INSTRUCTIONS: This application must be completed and filed with the school district. In order for an application to be processed, the governing body (school board) must elect to consider an application, but — by Comptroller rule — the school board may elect to consider the application only after the school district has received a completed application. Texas Tax Code, Section 313.025 requires that any completed application and any supplemental materials received by the school district must be forwarded within seven days to the Comptroller of Public Accounts.

If the school board elects to consider the application, the school district must:

- notify the Comptroller that the school board has elected to consider the application. This notice must include:
 - the date on which the school district received the application;

 - a request that the Comptroller prepare an economic impact analysis of the application;

- must complete the sections of the application reserved for the school district and provide information required in the Comptroller rules located at 34 Texas Administrative Code (TAC) Section 9.1054; and
- forward the original hard copy of the completed application to the Comptroller in a three-ring binder with tabs, as indicated on page 9 of this application, separating each section of the documents, in addition to an electronic copy on CD. See 34 TAC Chapter 9, Subchapter F.

The governing body may, at its discretion, allow the applicant to supplement or amend the application after the filing date, subject to the restrictions in 34 TAC Chapter 9, Subchapter F.

When the Comptroller receives the notice and required information from the school district, the Comptroller will publish all submitted application materials on its website. The Comptroller is authorized to treat some application information as confidential and withhold it from publication on the Internet. To do so, however, the information must be segregated and comply with the other requirements set out in the Comptroller rules. For more information, see guidelines on Comptroller's website.

The Comptroller will independently determine whether the application has been completed according to the Comptroller's rules (34 TAC Chapter 9, Subchapter F). If the Comptroller finds the application is not complete, the Comptroller will request additional materials from the school district. Pursuant to 9.1053(a)(1)(C), requested information shall be provided within 20 days of the date of the request. When the Comptroller determines that the application is complete, it will send the school district a notice indicating so. The Comptroller will determine the eligibility of the project, issue a certificate for a limitation on appraised value to the school board regarding the application and prepare an economic impact evaluation by the 90th day after the Comptroller receives a complete application—as determined by the Comptroller.

The school board must approve or disapprove the application not later than the 150th day after the application review start date (the date the application is finally determined to be complete), unless an extension is granted. The Comptroller and school district are authorized to request additional information from the applicant that is reasonably necessary to issue a certificate, complete the economic impact evaluation or consider the application at any time during the application review period.

State and local tax incentives contribute to the lowering of the cost of power sold to our customers and making our investment more viable and marketable. Origis has various projects in development throughout the country and are continually comparing investment opportunities, rate of return, and market viability of each project based upon project financial metrics. For example, Origis currently has ongoing project developments in many states, including but not limited to, Alabama, Georgia, Florida, Idaho, Maryland, Mississippi and Oregon.






Rockhound Solar A, LLC requests that the Ector County Independent School District's Board of Trustees waive the job requirement provision as allowed by Section 313.025(f-1) of the Tax Code. This waiver would be based on the school district's board findings that the jobs creation requirement exceeds the industry standard for the number of employees reasonably necessary for the operation of the facility of the property owner that is described in the application.

Rockhound Solar A, LLC requests that the Board of Trustees make such a finding and waive the job creation requirement for 10 permanent jobs. In line with industry standards for job requirements, Rockhound Solar A, LLC has committed to create two total jobs for the project.

Solar projects create a large number of full and part-time, but temporary, jobs during the construction phase of the project, but require a relatively small number of highly skilled technicians to operate and maintain the project after commercial operation commences. The number of jobs committed to in this application is in line with the industry standards for a solar project this size. This is evidenced by previously certified limitation agreement applications by solar developers who also requested a waiver of the job requirements. In addition, there are educational materials and other documentation that also suggest that Rockhound Solar A, LLC has the appropriate number of jobs for this project at one permanent job per 125MW of installed capacity.

The permanent employees of a solar project maintain and service PV panels, and inverters, underground electrical connections, substations and other infrastructure associated with the safe and reliable operation of the project. In addition to the onsite employees, there may be managers or technicians who support the project from offsite locations.

COUNTY OF ECTOR CHAPTER 381 ECONOMIC DEVELOPMENT PROGRAM – GUIDELINES & CRITERIA

SECTION 1. PURPOSE

It is the policy of Ector County to provide incentives to selected private businesses that make or will make a measureable difference in achieving economic growth and development, expanding and diversifying the tax base and creating new quality jobs within Ector County.

The purpose of this policy is to define the financial incentives and to establish standards for implementation. New businesses or expansion of existing businesses can be considered for financial incentives. In order to be eligible for incentives, businesses or individuals must be current on all County taxes or any other obligation to the County.

Incentives cannot be transferred as a result of a change in the majority ownership of the business without the expressed written consent of Ector County. Any new owner shall file a new application for an economic development incentive. It shall be the responsibility of the business to notify the County of any such substantive change.

Ector County is under no obligation to approve any requested incentive and no right to these incentives is neither intended nor implied.

SECTION 11. STRATEGIC OBJECTIVES

Ector County, through the implementation of this policy, shall endeavor to accomplish the following strategic objectives:

1. Ector County will pursue a stable, year-round economy with an emphasis on targeting quality jobs. A quality job is defined as a job that pays a wage or salary equal to or greater than the current Ector County Median Wage as computed annually by the Texas Workforce Commission and provides health insurance benefits to employees for which the employer pays at least 50%.
2. Ector County supports the retention and expansion of existing businesses within the County.
3. Ector County supports large private commercial recreational and tourism ventures that attract a Regional or National client base.
4. Ector County supports the revitalization of identified redevelopment areas and enterprise zones.
5. Ector County supports the attraction and retention of companies that have strong Regional and National markets for their products or services.
6. Ector County's economic development efforts should be consistent with the County's growth and development plans for Ector County.
7. Ector County supports increased health care coverage as a strategic objective.

SECTION III. GENERAL CRITERIA

Ector County may provide incentives for any business or commercial development project ("Project") if that project:

1. Will substantially enhance the economic health of Ector County.
2. Will result in a net increase or retention of jobs in the County or add to the tax base or will otherwise improve or enhance the economic welfare of the residents or businesses of the County; or
3. Demonstrates the potential to generate revenues to the County which outweigh costs associated with incentives.

In addition, the following criteria must be satisfied.

The project MUST:

1. Show a clear demonstration of public purpose and economic benefit through advancement of the County's economic goals which include expanding the tax base, creating quality jobs, increasing private capital investment in the community, spurring development in targeted county locations; or encouraging development of targeted businesses or clusters desirable to enhance the County's economy;
2. Include solid evidence provided by the business that demonstrates the business's financial stability and capacity to complete the project;
3. Be in compliance with all local, state and federal laws.

The business, in order to receive any such incentives from Ector County will make available credible information, including but not limited to capital investment and employment projections, to enable Ector County to prepare a fiscal impact analysis. The recipient will also make available an update of this data available annually after business operations have begun. The decision to provide any economic development incentives will be considered on a project-by-project basis, in accordance with the criteria set forth in this policy, and at the discretion of Ector County Commissioner's Court.

SECTION IV. QUALIFICATION CRITERIA

In order to be eligible for incentives, a project must meet all of the qualifying standards set forth below:

1. The Project agrees to locate within the area covered by Ector County.
2. The Project will produce a minimum of 150 new jobs in Ector County. New jobs do not include positions that are relocated from another location in Ector County.
3. The Project's investment must meet or exceed \$25,000,000 in infrastructure.
4. The Project must maintain ownership of all property for which a grant is received through the duration of the granting period.
5. The Project must make all efforts to hire local contractors and purchase items for construction from vendors within Ector County.
6. The Project will not knowingly employ undocumented workers.

Projects qualifying under this Category will be eligible for a maximum 50% Grant. Final Percentage of all grants will be at the sole discretion of the Commissioner's Court.

SECTION V. ECONOMIC DEVELOPMENT INCENTIVE

Companies meeting the qualification standards above who wish to pursue incentives will need to pay a \$250 non refundable application fee in order to formally request incentives.

An economic impact analysis will be conducted by Ector County on every project considered for incentives. The delivery mechanism of choice for incentives will be the Chapter 381 agreement; however, the County reserves the right to use any other source available in the award of incentives. As a matter of general policy, tax abatements and Chapter 381 agreements entered into as a result of this policy will not be used simultaneously unless the revenue stream from which the Chapter 381 agreement is paid is derived from sources other than property tax.

Agreements will be conditioned on the completion of specific improvements to real property and/or job numbers and salaries levels being met. The Agreements shall contain recapture clauses in the event that such conditions are not met.

AMENDMENTS

This policy may be amended or renewed by majority vote of Ector County Commissioner’s Court.


