They are existing property at this time not eligible to become qualified property (even though you will be tearing them down).

Response: As of the date of the application, there are only two temporary met towers in the reinvestment zone and project boundary (which are the same). The permanent met towers and collector substation do not currently exist and will be constructed as part of the project. The switch yard is under construction by AEP, the area utility company, and is not owned by the applicant and, as noted on the map in Tab 11, is shown only for informational purposes. Attached is a letter from Knox CAD that the value of the temporary met towers is zero for 2018, the last year for which certified tax values have been determined. Attached is information from Knox County Appraisal District showing that there is no improvement value on the 5.5 acre tract where AEP is building the new substation.










