As a result of an Amended Agreement for the Limitation of Appraised Value with Kermit Independent School District the description of the qualified property has changed. The amended description include (in addition to the original property) a 36Megawatt/24 Megawatt per hour battery storage unit to be housed in a separate building, together with appurtenances to the original installation, to be located within the reinvestment zone.
