Additional Information and Calculations

The required qualifying job annual wage was calculated as follows:

1. Chapter 313.051 is applicable because Scurry County was an area qualified as a strategic investment area before that subchapter expired.¹
2. Pursuant to 313.051(b), a property owner is required to create only at least 10 new jobs on the owner's qualified property.²
3. Further, at least 80% of these jobs (8 total) must be qualifying jobs, except that a qualifying job must pay 110% of the average weekly wage for manufacturing jobs in the region.³
4. Scurry County is in the West Central WDA.⁴
5. Pursuant to the most recent data compiled by the Texas Workforce Commission, the mean annual wage for all jobs in the manufacturing industry in the West Central WDA is \$33,904.⁵
6. At the 110% rate required by 313.051(b), the required annual wage for a qualifying job is \$37,294.
7. Thus, Scurry County Wind is required to employ at least 8 people at an annual wage of at least \$37,294.
